Naked Lunch (first published as The Naked Lunch) is a 1959 novel by American author William S. Burroughs. The novel does not follow a clear linear plot, but is instead structured as a series of non-chronological "routines". Many of these routines follow William Lee, an opioid addict who travels to the surreal city of Interzone and begins working for the organization "Islam Inc."

Burroughs wrote Naked Lunch while living in the Tangier International Zone, which inspired the book's Interzone setting. There, he witnessed escalating tensions between European powers and the Moroccan Nationalist Movement, which are reflected in Interzone's fictional political struggles. Burroughs also struggled with opioid addiction, which the novel describes extensively, although critics disagree whether the novel uses opioids as a metaphor for broader forms of control.

The novel was highly controversial for its depictions of drug use, sadomasochism, and body horror, including a famous description of a man's talking anus taking over his body. The book was considered obscene by the United States Postal Service, the state of Massachusetts, and the city of Los Angeles, each leading to separate legal challenges. In the Massachusetts trial, now recognized as a landmark censorship case, defense attorney Edward de Grazia called writers such as Allen Ginsberg, John Ciardi, and Norman Mailer to testify to the book's literary merit. Although the court initially ruled the book was in fact obscene, this decision was overturned by the Massachusetts Supreme Judicial Court, which allowed the book to be sold.

Naked Lunch has received a divided critical response. The book's admirers have compared it to the satires of Jonathan Swift and the religious works of Dante Aligheri and Hieronymous Bosch. Its detractors have

compared it to pornography, often calling it monotonous and boring. The book has been considered dystopian science fiction, postmodern, parodic, and picaresque. Its experimental techniques have been highly influential on rock music and the cyberpunk genre. *Naked Lunch* is considered one of the defining texts of the Beat Generation.

No such thing as a free lunch

such thing as a free lunch (also written as *There ain't no such thing as a free lunch* or *There is no such thing as a free lunch*; and sometimes called

"No such thing as a free lunch" (also written as "There ain't no such thing as a free lunch" or "There is no such thing as a free lunch" and sometimes called Crane's law) is a popular adage communicating the idea that it is impossible to get something for nothing. The acronyms TANSTAAFL, TINSTAAFL, and TNSTAAFL are also used. The phrase was in use by the 1930s, but its first appearance is unknown. The "free lunch" in the saying refers to the formerly common practice in American bars of offering a "free lunch" in order to entice drinking customers.

The phrase and the acronym are central to Robert A. Heinlein's 1966 science-fiction novel *The Moon is a Harsh Mistress*, which helped popularize it. The free-market economist Milton Friedman also increased its exposure and use by paraphrasing it as the title of a 1975 book; it is used in economics literature to describe opportunity cost. Campbell McConnell writes that the idea is "at the core of economics".

Cupbop started out in 2013 as a food truck in Salt Lake County, Utah and has since grown to other states. The restaurant is credited with bringing Korean BBQ to Utah. As of June 2024, in the United States there are 64 total store locations, six food trucks, and several concessions locations including the Utah Jazz NBA Arena. The chain also operates over 180 locations throughout Indonesia. In 2024 the chain saw \$64 million in annual revenue.

The plate lunch (Hawaiian: pō mea ʻai) is a Hawaiian meal, roughly analogous to the Southern U.S. meat-and-three or Japanese bento box. The combination of Polynesian, North American and East Asian cuisine arose naturally in Hawaii, and has spread beyond it.

Standard plate lunches consist of one or two scoops of white rice, macaroni salad (in an American style), and an entrée (usually in a Japanese style such as chicken katsu or teriyaki). A plate lunch with more than one entrée is often called a "mixed plate".

Backchannel is the use of networked computers to maintain a real-time online conversation alongside the primary group activity or live spoken remarks. The term was coined from the linguistics term to describe listeners' behaviours during verbal communication.

The term "backchannel" generally refers to online conversation about the conference topic or speaker. Occasionally backchannel provides audience members a chance to fact-check the presentation.

First growing in popularity at technology conferences, backchannel is increasingly a factor in education where WiFi connections and laptop computers allow participants to use ordinary chat like IRC or AIM to actively communicate during presentation. More recent research include works where the backchannel is brought publicly visible, such as the ClassCommons, backchan.nl and Fragmented Social Mirror.

Twitter is also widely used today by audiences to create backchannels during broadcasting of content or at conferences. For example, television drama, other forms of entertainment and magazine programs. This practice is often also called live tweeting. Many conferences nowadays also have a hashtag that can be used by the participants to share notes and experiences; furthermore such hashtags can be user generated.

It was a staged photograph arranged as a publicity stunt, part of a campaign promoting the skyscraper.

The photographic negative is in the Bettmann Archive, owned by the Visual China Group. The image is often misattributed to Lewis Hine, but the identity of the actual photographer remains unclear. Evidence emerged indicating it may have been taken by Charles C. Ebbets, but it was later found that other photographers had been present at the shoot as well. Many claims have been made regarding the identities of the men in the image, though only a few have been definitively identified. Ken Johnston, manager of the historic collections of Corbis, called the image "a piece of American history".
