The modern Celts (KELTS, see pronunciation of Celt) are a related group of ethnicities who share similar Celtic languages, cultures and artistic histories, and who live in or descend from one of the regions on the western extremities of Europe populated by the Celts.

A modern Celtic identity emerged in Western Europe following the identification of the native peoples of the Atlantic fringe as Celts by Edward Lhuyd in the 18th century. Lhuyd and others (notably the 17th century Breton chronologist Pezron) equated the Celts described by Greco-Roman writers with the pre-Roman peoples of France, Great Britain, and Ireland. They categorised the ancient Irish and British languages as Celtic languages. The descendants of these ancient languages are the Brittonic (Breton, Cornish, and Welsh variants) and Goidelic (Irish, Manx, and Gaelic variants) languages, and the people who speak them are considered modern Celts.

The concept of modern Celtic identity evolved during the course of the 19th century into the Celtic Revival. By the late 19th century, it often took the form of ethnic nationalism, particularly within the United Kingdom of Great Britain and Ireland, where the Irish War of Independence resulted in the secession of the Irish Free State, in 1922. There were also significant Welsh, Scottish, and Breton nationalist movements, giving rise to the concept of Celtic nations. After World War II, the focus of the Celtic movement shifted to linguistic revival and protectionism, e.g. with the foundation of the Celtic League in 1961, dedicated to preserving the surviving Celtic languages.

The Celtic revival also led to the emergence of musical and artistic styles identified as Celtic. Music typically drew on folk traditions within the Celtic nations. Art drew on the decorative styles of Celtic art produced by the ancient Celts and early medieval Christianity, along with folk styles. Cultural events to promote "inter-Celtic" cultural exchange also emerged.

In the late 20th century, some authors criticised the idea of modern Celtic identity, usually by downplaying the value of the linguistic component in defining culture and cultural connection, sometimes also arguing that there never was a common Celtic culture, even in ancient times. Malcolm Chapman's 1992 book *The Celts: The Construction of a Myth* led to what archaeologist Barry Cunliffe has called a "politically correct disdain for the use of 'Celt.'"

The Celts (KELTS, see pronunciation for different usages) or Celtic peoples (KEL-tik) were a collection of Indo-European peoples in Europe and Anatolia, identified by their use of Celtic languages and other cultural similarities. Major Celtic groups included the Gauls; the Celtiberians and Gallaeci of Iberia; the Britons, Picts, and Gaels of Britain and Ireland; the Boii; and the Galatians. The interrelationships of ethnicity, language and culture in the Celtic world are unclear and debated; for example over the ways in which the Iron Age people of Britain and Ireland should be called Celts. In current scholarship, 'Celt' primarily refers to

'speakers of Celtic languages' rather than to a single ethnic group.

The history of pre-Celtic Europe and Celtic origins is debated. The traditional "Celtic from the East" theory, says the proto-Celtic language arose in the late Bronze Age Urnfield culture of central Europe, named after grave sites in southern Germany, which flourished from around 1200 BC. This theory links the Celts with the Iron Age Hallstatt culture which followed it (c. 1200–500 BC), named for the rich grave finds in Hallstatt, Austria, and with the following La Tène culture (c. 450 BC onward), named after the La Tène site in Switzerland. It proposes that Celtic culture spread westward and southward from these areas by diffusion or migration. A newer theory, "Celtic from the West", suggests proto-Celtic arose earlier, was a lingua franca in the Atlantic Bronze Age coastal zone, and spread eastward. Another newer theory, "Celtic from the Centre", suggests proto-Celtic arose between these two zones, in Bronze Age Gaul, then spread in various directions. After the Celtic settlement of Southeast Europe in the 3rd century BC, Celtic culture reached as far east as central Anatolia, Turkey.

The earliest undisputed examples of Celtic language are the Lepontic inscriptions from the 6th century BC. Continental Celtic languages are attested almost exclusively through inscriptions and place-names. Insular Celtic languages are attested from the 4th century AD in Ogham inscriptions, though they were being spoken much earlier. Celtic literary tradition begins with Old Irish texts around the 8th century AD. Elements of Celtic mythology are recorded in early Irish and early Welsh literature. Most written evidence of the early Celts comes from Greco-Roman writers, who often grouped the Celts as barbarian tribes. They followed an ancient Celtic religion overseen by druids.

The Celts were often in conflict with the Romans, such as in the Roman–Gallic wars, the Celtiberian Wars, the conquest of Gaul and conquest of Britain. By the 1st century AD, most Celtic territories had become part of the Roman Empire. By c. 500, due to Romanisation and the migration of Germanic tribes, Celtic culture had mostly become restricted to Ireland, western and northern Britain, and Brittany. Between the 5th and 8th centuries, the Celtic-speaking communities in these Atlantic regions emerged as a reasonably cohesive cultural entity. They had a common linguistic, religious and artistic heritage that distinguished them from surrounding cultures.

Insular Celtic culture diversified into that of the Gaels (Irish, Scots and Manx) and the Celtic Britons (Welsh, Cornish, and Bretons) of the medieval and modern periods. A modern Celtic identity was constructed as part of the Romanticist Celtic Revival in Britain, Ireland, and other European territories such as Galicia. Today, Irish, Scottish Gaelic, Welsh, and Breton are still spoken in parts of their former territories, while Cornish and Manx are undergoing a revival.

The Celtic languages (KEL-tik) are a branch of the Indo-European language family, descended from the hypothetical Proto-Celtic language. The term "Celtic" was first used to describe this language group by Edward Lhuyd in 1707, following Paul-Yves Pezron, who made the explicit link between the Celts described by classical writers and the Welsh and Breton languages.

During the first millennium BC, Celtic languages were spoken across much of Europe and central Anatolia. Today, they are restricted to the northwestern fringe of Europe and a few diaspora communities. There are six living languages: the four continuously living languages Breton, Irish, Scottish Gaelic and Welsh, and the two revived languages Cornish and Manx. All are minority languages in their respective countries, though there are continuing efforts at revitalisation. Welsh is an official language in Wales and Irish is an official language across the island of Ireland and of the European Union. Welsh is the only Celtic language not classified as endangered by UNESCO. The Cornish and Manx languages became extinct in modern times but

have been revived. Each now has several hundred second-language speakers.

Irish, Manx and Scottish Gaelic form the Goidelic languages, while Welsh, Cornish and Breton are Brittonic. All of these are Insular Celtic languages, since Breton, the only living Celtic language spoken in continental Europe, is descended from the language of settlers from Britain. There are a number of extinct but attested Continental Celtic languages, such as Celtiberian, Galatian and Gaulish. Beyond that, there is no agreement on the subdivisions of the Celtic language family. Traditionally, they are considered to be divided into P-Celtic and Q-Celtic. However, Gaulish is widely considered more closely related to Insular Celtic than either of these two are to Celtiberian; together, Gaulish and Insular Celtic may form the Nuclear Celtic subfamily.

The Celtic languages have a rich literary tradition. The earliest specimens of written Celtic are Lepontic inscriptions from the 6th century BC in the Alps. Early Continental inscriptions used Italic and Paleohispanic scripts. Between the 4th and 8th centuries, Irish and Pictish were occasionally written in an original script, Ogham, but Latin script came to be used for all Celtic languages. Welsh has had a continuous literary tradition from the 6th century AD.

Pan-Celticism (Irish: Pan-Cheilteachas, Scottish Gaelic: Pan-Cheilteachas, Breton: Pan-Keltaidd, Welsh: Pan-Geltaidd, Cornish: Pan-Keltaidh, Manx: Pan-Cheltaghys), also known as Celticism or Celtic nationalism, is a political, social and cultural movement advocating solidarity and cooperation between Celtic nations (both the Brythonic and Gaelic branches) and the modern Celts in Northwestern Europe. Some pan-Celtic organisations advocate the Celtic nations seceding from the United Kingdom and France and forming their own separate federal state together, while others simply advocate very close cooperation between independent sovereign Celtic nations, in the form of Breton, Cornish, Irish, Manx, Scottish, and Welsh nationalism.

Just like other pan-nationalist movements, the pan-Celtic movement grew out of Romantic nationalism and specific to itself, the Celtic Revival. The pan-Celtic movement was most prominent during the 19th and 20th centuries (roughly 1838 until 1939). Some early pan-Celtic contacts took place through the Gorsedd and the Eisteddfod, while the annual Celtic Congress was initiated in 1900. Since that time the Celtic League has become the prominent face of political pan-Celticism. Initiatives largely focused on cultural Celtic cooperation, rather than explicitly politics, such as music, arts and literature festivals, are usually referred to instead as inter-Celtic.

Nationalism and archaeology have been closely related since at least the nineteenth century. Archaeological interpretations and ancient history can be manipulated for nationalist purposes, such as cultivating national mythologies and national mysticism. Frequently this involves the uncritical identification of one's own ethnic group with some ancient or even prehistoric (known only archaeologically) group, whether mainstream

scholarship accepts as plausible or rejects as pseudoarchaeology the historical derivation of the contemporary group from the ancient one. The decisive point, often assumed implicitly, that it is possible to derive nationalist or ethnic pride from a population that lived millennia ago and, being known only archaeologically or epigraphically, is not remembered in living tradition.

Examples include Kurds claiming identity with the Medes, Albanians claiming as their origin the Illyrians, Iraqi propaganda invoking Sumer or Babylonia, Hindu nationalists and Tamils claiming as their origin the Indus Valley civilisation—all of the mentioned groups being known only from either ancient historiographers or archaeology. In extreme cases, nationalists will ignore the process of ethnogenesis altogether and claim ethnic identity of their own group with some scarcely attested ancient ethnicity known to scholarship by the chances of textual transmission or archaeological excavation.

The genetic history of the British Isles is the subject of research within the larger field of human population genetics. It has developed in parallel with DNA testing technologies capable of identifying genetic similarities and differences between both modern and ancient populations. The conclusions of population genetics regarding the British Isles in turn draw upon and contribute to the larger field of understanding the history of the human occupation of the area, complementing work in linguistics, archaeology, history and genealogy.

Research concerning the most important routes of migration into the British Isles is the subject of debate. Apart from the most obvious route across the narrowest point of the English Channel into Kent, other routes may have been important over the millennia, including a land bridge in the Mesolithic period, as well as maritime connections along the Atlantic coasts.

Genetic studies have revealed multiple migration waves into Britain and Ireland from the Palaeolithic onwards, with detectable regional differences among present-day populations. After the Last Glacial Maximum, hunter-gatherer groups carrying two distinct ancestries (GoyetQ2-related and Villabruna-related) repopulated Britain and Ireland, with the latter eventually becoming dominant. This hunter-gatherer ancestry was substantially replaced during the Neolithic revolution, c. 4000 BC, by groups carrying Early European Farmer (EEF) ancestry from the European mainland, who admixed to a certain extent with the existing hunter-gatherer population in some regions. At the start of the Bronze Age, another major population replacement occurred when migrating Bell Beaker groups, carrying a high proportion of Steppe-related ancestry, replaced around 90% of the Neolithic gene pool. Throughout the Bronze and Iron Ages, further migration from mainland Europe raised the proportion of Early European Farmer ancestry in southern Britain. This has been proposed as one possible mechanism for the introduction of Celtic languages.

Other potentially important historical periods of migration that have been subject to consideration in this field include the Roman era, the period of early Germanic influx, the Viking era, the Norman invasion of 1066, and the era of the European wars of religion.

Historiography is the study of how history is written. One pervasive influence upon the writing of history has been nationalism, a set of beliefs about political legitimacy and cultural identity. Nationalism has provided a significant framework for historical writing in Europe and in those former colonies influenced by Europe since the nineteenth century. Typically official school textbooks are based on the nationalist model and focus

on the emergence, trials and successes of the forces of nationalism.

The Latins (Latin: Latīni), sometimes known as the Latials or Latians, were an Italic tribe that included the early inhabitants of the city of Rome (see Roman people). From about 1000 BC, the Latins inhabited the small region known to the Romans as Old Latium (in Latin Latium vetus), the area in the Italian Peninsula between the river Tiber and the promontory of Mount Circeo 100 km (62 mi) southeast of Rome. Following the Roman expansion, the Latins spread into the Latium adiectum, inhabited by Osco-Umbrian peoples.

Their language, Latin, belonged to the Italic branch of Indo-European. Speakers of Italic languages are assumed to have migrated into the Italian Peninsula during the late Bronze Age (1200–900 BC). The material culture of the Latins, known as the Latial culture, was a distinctive subset of the proto-Villanovan culture that appeared in parts of the Italian peninsula in the first half of the 12th century BC. Before and after their political unification under Rome in 338 BC, the Latins maintained close cultural and religious relations, including common festivals and religious sanctuaries.

The rise of Rome as by far the most populous and powerful Latin state from c. 600 BC led to volatile relations with the other Latin states, which numbered about 14 in 500 BC. In the period of the Tarquin monarchy (c. 550–500 BC), Rome apparently acquired political hegemony over the other states. After the fall of the Roman monarchy around 500 BC, there appears to have been a century of military alliance between Rome and the other Latin states to confront the threat posed to all Latium by raiding by the surrounding Italic mountain tribes, especially the Volsci and Aequi. This system progressively broke down after roughly 390 BC, when Rome's aggressive expansionism led to conflict with other Latin states, both individually and collectively. In 341–338 BC, the Latin states jointly fought the Latin War against Rome in a final attempt to preserve their independence. The war ended in 338 BC with a decisive Roman victory. The other Latin states were either annexed or permanently subjugated to Rome.

The Roman Empire ruled the Mediterranean and much of Europe, Western Asia and North Africa. The Romans conquered most of this during the Republic, and it was ruled by emperors following Octavian's assumption of effective sole rule in 27 BC. The western empire collapsed in 476 AD, but the eastern empire lasted until the fall of Constantinople in 1453.

By 100 BC, the city of Rome had expanded its rule from the Italian peninsula to most of the Mediterranean and beyond. However, it was severely destabilised by civil wars and political conflicts, which culminated in the victory of Octavian over Mark Antony and Cleopatra at the Battle of Actium in 31 BC, and the subsequent conquest of the Ptolemaic Kingdom in Egypt. In 27 BC, the Roman Senate granted Octavian overarching military power (imperium) and the new title of Augustus, marking his accession as the first Roman emperor. The vast Roman territories were organized into senatorial provinces, governed by proconsuls who were appointed by lot annually, and imperial provinces, which belonged to the emperor but were governed by legates.

The first two centuries of the Empire saw a period of unprecedented stability and prosperity known as the Pax Romana (lit. 'Roman Peace'). Rome reached its greatest territorial extent under Trajan (r. 98–117 AD), but a period of increasing trouble and decline began under Commodus (r. 180–192). In the 3rd century, the Empire underwent a 49-year crisis that threatened its existence due to civil war, plagues and barbarian

invasions. The Gallic and Palmyrene empires broke away from the state and a series of short-lived emperors led the Empire, which was later reunified under Aurelian (r. 270–275). The civil wars ended with the victory of Diocletian (r. 284–305), who set up two different imperial courts in the Greek East and Latin West. Constantine the Great (r. 306–337), the first Christian emperor, moved the imperial seat from Rome to Byzantium in 330, and renamed it Constantinople. The Migration Period, involving large invasions by Germanic peoples and by the Huns of Attila, led to the decline of the Western Roman Empire. With the fall of Ravenna to the Germanic Herulians and the deposition of Romulus Augustus in 476 by Odoacer, the Western Empire finally collapsed. The Byzantine (Eastern Roman) Empire survived for another millennium with Constantinople as its sole capital, until the city's fall in 1453.

Due to the Empire's extent and endurance, its institutions and culture had a lasting influence on the development of language, religion, art, architecture, literature, philosophy, law, and forms of government across its territories. Latin evolved into the Romance languages while Medieval Greek became the language of the East. The Empire's adoption of Christianity resulted in the formation of medieval Christendom. Roman and Greek art had a profound impact on the Italian Renaissance. Rome's architectural tradition served as the basis for Romanesque, Renaissance, and Neoclassical architecture, influencing Islamic architecture. The rediscovery of classical science and technology (which formed the basis for Islamic science) in medieval Europe contributed to the Scientific Renaissance and Scientific Revolution. Many modern legal systems, such as the Napoleonic Code, descend from Roman law. Rome's republican institutions have influenced the Italian city-state republics of the medieval period, the early United States, and modern democratic republics.
