The Oregon Files is a series of novels written by author Clive Cussler and several co-authors. Craig Dirgo was a co-writer for the first two titles, Jack Du Brul was a co-writer for the next seven titles, Boyd Morrison took over as co-writer starting with book 10, and Mike Maden writes the 16th, 17th, and 18th book after Clive's passing.

The books follow the mysterious "Corporation" and its leader Juan Cabrillo. The title of the series, "Oregon Files", comes from the name of the corporation's ship, the Oregon. The ship's name is based on the former name of the TS Empire State VI, which originally had the name SS Oregon before entering into government service as a training ship for the United States Maritime Service.

On November 19, 2006, the Wii launch was accompanied by 20 launch games. The last game releases for the Wii, Retro City Rampage DX+ and Shakedown: Hawaii, were released on July 9, 2020 exclusively in Europe. There are 1612 games on this list.

Gunfight at the O.K. Corral

extra-legal campaign for revenge captured people \$\'\$; attention. The gunfight and its aftermath stand for the change overcoming America as the Western frontier ceased

The gunfight at the O.K. Corral pitted lawmen against members of a loosely organized group of cattle rustlers and horse thieves called the Cochise County Cowboys on October 26, 1881. While lasting less than a minute, the gunfight has been the subject of books and films into the 21st century. Taking place in the town of Tombstone in Arizona Territory, the battle has become one archetype of the American Old West. The gunfight was the result of a long-simmering feud between five outlaws (including two sets of brothers) and four representatives of the law, including three brothers. The trigger for the event was the local marshal's decision to enforce a city ordinance that prohibited the carrying of weapons into town. To enforce that ordinance, the lawmen would have to disarm the Cowboys.

Among the lawmen were three brothers, Virgil, Wyatt, and Morgan Earp, as well as Wyatt's close friend Doc Holliday. As Deputy U.S. Marshal and Town Marshal, Virgil was in charge, and it was his decision to enforce the ordinance that led to the shoot out. His two brothers and Doc Holliday were temporary assistant marshals. The Cowboys were a loosely connected group of outlaws. In Tombstone at the time of the gunfight

were five members of the Cowboys: Billy Claiborne, brothers Ike and Billy Clanton, and brothers Tom and Frank McLaury. Despite its name, the gunfight did not take place within or next to the O.K. Corral, which fronted Allen Street and had a rear entrance lined with horse stalls on Fremont Street. The shootout actually took place in a narrow lot on the side of C. S. Fly's photography studio on Fremont Street, six doors west of the O.K. Corral's rear entrance. Some members of the two opposing parties were initially only about 6 feet (1.8 m) apart. About thirty shots were fired in thirty seconds. During that brief battle, three men were killed, three were wounded, two ran away, and one fought but was unharmed. Ike Clanton subsequently filed murder charges against the Earps and Holliday. After a thirty-day preliminary hearing and a brief stint in jail, the defendants were shown to have acted lawfully.

The gunfight was not the end of the conflict. On December 28, 1881, Virgil was ambushed and maimed in a murder attempt by the Cowboys. On March 18, 1882, a Cowboy fired from a dark alley through the glass door of Campbell & Hatch's saloon and billiard parlor, killing Morgan. The suspects in both incidents furnished alibis supplied by other Cowboys and were not indicted. Wyatt, newly appointed as Deputy U.S. Marshal in Cochise County, then took matters into his own hands in a personal vendetta. He was pursued by county sheriff Johnny Behan, who had received a warrant from Tucson for Wyatt's killing of Frank Stilwell.

The gunfight was not widely known until two years after Wyatt Earp's death, when Stuart Lake published his 1931 book Wyatt Earp: Frontier Marshal. The book was the basis for the 1939 film Frontier Marshal, with Randolph Scott and Cesar Romero, the 1946 film My Darling Clementine, directed by John Ford, and the 1957 film Gunfight at the O.K. Corral, after which the shootout became known by that name. The shootout was also depicted in the 1993 film Tombstone and the next year in Kevin Costner's less well received film Wyatt Earp. Since then, the conflict has been portrayed with varying degrees of accuracy in numerous Western films and books, and has become an archetype for much of the popular imagery associated with the Old West.

William L. Brooks

William L. "Buffalo Bill" Brooks (c. 1832 – July 29, 1874) was a western lawman and later outlaw.

Brooks was born in Ohio around 1832 where he later became a buffalo hunter in the late-1840s or early-1850s whose success equaled fellow buffalo hunter William F. Cody earning the same nickname of Buffalo Bill. During the late 1860s, Brooks had killed several men in various gunfights, and was briefly hired as a stage driver for the Southwestern Stage Co., before becoming the marshal of Newton, Kansas in 1872. Although he was reported to have been around 40 years old, several biographers have claimed Brooks was in his 20s.

With Brooks' success in Newton he was soon offered a position in Dodge City as town marshal where he was later involved in 15 gunfights during his first month. In one case one of the men killed had four brothers who came after Brooks in revenge. As the brothers arrived in town Brooks was said to have killed all four men

with four shots each. By the following year Brooks had cleared the city of most major criminals. Brooks however killed several men in questionable circumstances including one incident where he killed a man over an argument with a local dance hall girl. After backing down from gunfighter Kirk Jordan, Brooks left town shortly after.

According to legend, Brooks went to Butte, Montana where he attempted to become the city marshal but, in part because of Brook's reputation, was instead passed over in favor of Morgan Earp. Confronting Earp over his defeat, Brooks was shot in the stomach and Morgan was shot in the shoulder.

Records show however that, shortly after leaving Dodge City, Brooks returned to his old position as a stage driver for the Southwestern Stage Co. in early 1874. Several months later however the company had lost a mail contract to a rival company and Brooks lost his job. In June several mules and horses owned by the rival company had been stolen and Brooks, with two other men, were arrested the next month. It was charged that Brooks had apparently attempted to weaken the rival company and win back the mail contract for the Southwestern Stage Company. Brooks was lynched while awaiting trial on July 29, 1874.
