Coretta Scott King Award

The Coretta Scott King Award is an annual award presented by the Coretta Scott King Book Award Round Table, part of the American Library Association (ALA)

The Coretta Scott King Award is an annual award presented by the Coretta Scott King Book Award Round Table, part of the American Library Association (ALA). Named for Coretta Scott King, wife of Martin Luther King Jr., this award recognizes outstanding books for young adults and children by African Americans that reflect the African American experience. Awards are given both to authors and to illustrators for universal human values.

The first author award was given in 1970. In 1974, the award was expanded to honor illustrators as well as authors. Starting in 1978, runner-up Author Honor Books have been recognized. Recognition of runner-up Illustrator Honor Books began in 1981.

In addition, the Coretta Scott King Awards committee has given the Virginia Hamilton Award for Lifetime Achievement, starting in 2010, and beginning in 1996 an occasional John Steptoe Award for New Talent.

Like the Newbery Medal and Caldecott Medal, the Coretta Scott King Awards have the potential to be used in classroom teaching and projects.

Coretta Scott King

Coretta Scott King (née Scott; April 27, 1927 – January 30, 2006) was an American author, activist, and civil rights leader who was the wife of Martin

As an advocate for African-American equality, she was a leader for the civil rights movement in the 1960s. King

was also a singer who often incorporated music into her civil rights work. King met her husband while attending graduate school in Boston. They both became increasingly active in the American civil rights movement.

King played a prominent role in the years after her husband's assassination in 1968, when she took on the leadership of the struggle for racial equality herself and became active in the Women's Movement. King founded the King Center, and sought to make his birthday a national holiday. She finally succeeded when Ronald Reagan signed legislation which established Martin Luther King Jr. Day on November 2, 1983. She later broadened her scope to include both advocacy for LGBTQ rights and opposition to apartheid. King became friends with many politicians before and after Martin's death, including John F. Kennedy, Lyndon B. Johnson, and Robert F. Kennedy. Her telephone conversation with John F. Kennedy during the 1960 presidential election has been credited by historians for mobilizing African-American voters.

In August 2005, King suffered a stroke which paralyzed her right side and left her unable to speak; five months later, she died of respiratory failure due to complications from ovarian cancer. Her funeral was attended by some 10,000 people, including U.S. presidents George W. Bush, Bill Clinton, George H. W. Bush and Jimmy Carter. She was temporarily buried on the grounds of the King Center until being interred next to her husband. She was inducted into the Alabama Women's Hall of Fame, the National Women's Hall of Fame, and was the first African American to lie in state at the Georgia State Capitol. King has been referred to as "First Lady of the Civil Rights Movement".

Her childhood experience was greatly influenced by her father's highly public activism.

She was born two weeks before Rosa Parks refused to give up her seat on a public transit bus in Montgomery, Alabama. She occasionally experienced threats to her life, designed to intimidate her parents, and was bullied at school. When her father was assassinated on April 4, 1968, the 12-year-old King showed her composure during the public funeral and mourning events. King joined her mother and siblings in marches and was lauded by such figures as Harry Belafonte, who established a trust fund for her and her siblings. She became a secondary caregiver to her younger siblings.

In her teenage years, she became an effective leader of her high school class and was covered by the magazines Jet and Ebony. Her teenage years were filled with more tragedies, specifically the sudden death of her uncle Alfred Daniel Williams King and the murder of her grandmother, Alberta Williams King. While in high school, she gained lifelong friends. It was the first and only institution where King was not harassed or mistreated because of who her father was. However, she was still misjudged and mistrusted because of her skin color, based on perceptions founded solely upon her relationship with her father. Despite this, King managed to keep up her grades and became involved in high school politics, serving as class president for two years. King aroused controversy in high school for her role in a play. She was credited with having her father's sense of humor.

In the 1990s, she supported a retrial of James Earl Ray and publicly stated that she did not hate him. That decade saw King's acting career take off as she appeared in ten separate projects, including Ghosts of Mississippi (1996), Our Friend, Martin (1999) and Selma, Lord, Selma (1999). By the time she was an adult, she had grown to become a supporter of gay rights and an ally to the LGBT community, as was her mother. She was involved in a sibling feud that pitted her and her brother Dexter against their brother Martin Luther

King III and sister Bernice King for the sale of the King Center in Atlanta, Georgia. King served as a spokesperson for her mother during the illness that would eventually lead to her death. King outlived her mother by only 16 months, succumbing to complications related to a chronic heart condition on May 15, 2007.

Death and funeral of Coretta Scott King

Coretta Scott King, the widow of civil rights leader Martin Luther King Jr., died on January 30, 2006, after arriving at a rehabilitation center in Rosarito, Baja California, Mexico. Her public funeral followed eight days later at the New Birth Missionary Baptist Church in her resident state of Georgia. In keeping with her personal wishes, King was buried next to her husband in a crypt on the grounds of the King Center for Nonviolent Social Change.

King suffered strokes throughout the year 2005, and had different brushes with diseases, including a mild heart attack. The clinic where Ms. King received medical attention gained exposure surrounding her death. The media coverage was mostly negative, and ultimately the clinic was shut down. Prior to this, King had been released from Piedmont Hospital in Atlanta after regaining some of her speech. Nearly two weeks later, King signed into the clinic in Mexico where she would eventually die. She was seventy-eight years old.

Bernice King

Bernice Albertine King (born March 28, 1963) is an American lawyer, minister, and the youngest child of civil rights leaders Martin Luther King Jr. and Coretta Scott King. She was five years old when her father was assassinated. In her adolescence, King chose to work towards becoming a minister after having a breakdown from watching a documentary about her father. King was 17 when she was invited to speak at the United Nations (UN). Twenty years after her father was assassinated, she preached her trial sermon, inspired by her parents' activism.

Her mother had a stroke in 2005, and then died in the following year 2006; King delivered the eulogy at her funeral. A turning point in her life, King experienced conflict within her family when her sister Yolanda and brother Dexter supported the sale of the King Center for Nonviolent Social Change. After her sister died in 2007, she delivered the eulogy for her as well. She supported the presidential campaign of Barack Obama in 2008 and called his nomination part of her father's dream.

King was known for her advocacy against gay rights, in contrast to the rest of her outspokenly pro-LGBT family, through the 2000s and early 2010s. She later seemed to retract these views in 2015.

King was elected president of the Southern Christian Leadership Conference in 2009. Her elder brother Martin III and her father had previously held the position. She was the first woman elected to the presidency in the organization's history, amidst the SCLC holding two separate conventions. King became upset with the actions of the SCLC, feeling that the organization was ignoring her suggestions, and declined the presidency in January 2010.

King became CEO of the King Center only months afterward. King's primary focus as CEO of The King Center and in life is to ensure that her father's nonviolent philosophy and methodology (which The King Center calls Nonviolence 365) is integrated in various sectors of society, including education, government, business, media, arts and entertainment and sports. King believes that Nonviolence 365 is the answer to society's problems and promotes it being embraced as a way of life. King is also the CEO of First Kingdom

Management, a Christian consulting firm based in Atlanta, Georgia.

Edythe Scott Bagley

Edythe Scott Bagley (December 13, 1924 – June 11, 2011) was an American author, activist, and educator. The older sister of Coretta Scott King, she worked

Edythe Scott Bagley (December 13, 1924 – June 11, 2011) was an American author, activist, and educator. The older sister of Coretta Scott King, she worked behind the scenes to promote the Civil Rights Movement and was actively involved in many of the crucial events of that era.

In 1943, Mrs. Bagley graduated from Lincoln Normal School in Marion, Alabama. With the encouragement of teachers and mentors, she applied for a scholarship to Antioch College and was accepted as a student there that fall. Though Antioch had enjoyed a long history of racial tolerance, Mrs. Bagley was the first African American student admitted to the school in the modern era. Later, she transferred to Ohio State University from which she graduated. She also earned a master of English from Columbia University and a master of fine arts from Boston University.

Assassination of Martin Luther King Jr.

in 1963, King told his wife, Coretta Scott King, "This is what is going to happen to me also. I keep telling you, this is a sick society." King traveled

Martin Luther King Jr., an American civil rights activist, was fatally shot at the Lorraine Motel in Memphis, Tennessee, on April 4, 1968, at 6:01 p.m. CST. He was rushed to St. Joseph's Hospital, where he was pronounced dead at 7:05 p.m at age 39.

The alleged assassin, James Earl Ray, an escaped convict from the Missouri State Penitentiary, was arrested on June 8, 1968, at London's Heathrow Airport, extradited to the United States and charged with the crime. On March 10, 1969, Ray pleaded guilty and was sentenced to 99 years in the Tennessee State Penitentiary. He later made many attempts to withdraw his guilty plea and to be tried by a jury, but was unsuccessful, before he died in 1998.

The King family and others believe that the assassination was the result of a conspiracy involving the U.S. government, the mafia, and Memphis police, as alleged by Loyd Jowers in 1993. They believe that Ray was a scapegoat. In 1999, the family filed a wrongful death lawsuit against Jowers for the sum of \$10 million. During the trial, both sides presented evidence alleging a government conspiracy. The accused government agencies could not defend themselves or respond because they were not named as defendants. Based on the evidence, the jury concluded that Jowers and others were "part of a conspiracy to kill King" and awarded the family the symbolic \$100 they requested in damages. The allegations and the finding of the Memphis jury were later disputed by the United States Department of Justice in 2000 due to perceived lack of evidence.

The assassination was one of four major assassinations of the 1960s in the United States, coming several years after the assassination of John F. Kennedy in 1963 and the assassination of Malcolm X in 1965, and two months before the assassination of Robert F. Kennedy in June 1968.

The Embrace is a bronze sculpture by Hank Willis Thomas, installed on Boston Common in Boston, Massachusetts, United States, in December 2022. The artwork commemorates Martin Luther King Jr. and Coretta Scott King, and depicts four intertwined arms, representing the hug they shared after he was awarded

the Nobel Peace Prize in 1964. The work was created by welding together about 609 smaller pieces. The sculpture has received largely negative responses from critics and the public.
